These prices are effective as of April 1, 2021 and are subject to change without notice. In compliance with the Federal Trade Commission regulations (16 CFR Part 453), we are required to provide you this general price list. #### SERVICES AND MERCHANDISE FOR SALE:

A. Our charge for direct cremation without ceremony include:

\*Professional and staff services, counselor for arrangements, administrative services including obtaining legally required signatures on necessary authorizations, (accompanying fees charged by individual counties are additional), automotive equipment within our service area, alternative container for cremation, crematory fee, & solid container for the return of cremated remains. This list does not include prices for certain items that you may ask us to buy for you, such as: cemetery services, newspaper notices, markers, or date work on markers. The price for those items you selected will be shown on your statement of funeral goods and services. \* We do not offer those services

If you wish to arrange a direct cremation, you may use an unfinished wood box (CSMM does not offer this type of container) or an alternative container. Alternative containers can be made of materials like heavy cardboard or composition materials (with or without an outside covering). **\* If purchaser provides the cremation container the price remains the same (no discount applies).** This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for cremation.)

**Alternative Containers-**Charge: **Included in our direct cremation package**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container that we provide (cardboard with fiberboard in the base of the container). This is our alternative container.

**Embalming –**Charge: None, **We do not offer embalming**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**Casket Price List -**Charge: **We do not offer caskets****Outer Burial Container Price List-**Charge: **\$160.00     Fiberglass urn vault**

State or local law does not require that you buy a container to surround the casket in the grave. However, many cemeteries require that you have such a container so the grave will not sink in. Either a grave liner or a burial vault will satisfy these requirements.

\* Please note, we do not sell caskets or burial vaults. If you are planning on burying cremated remains, it is your responsibility to contact your cemetery to determine if an urn vault is required. If an urn vault is required, you may purchase it from the cemetery or from us.
